- After approval, a \$25 non-refundable deposit is required to reserve a date at least two weeks in advance.
- The remaining balance must be paid at least 1 week prior to the date of the rental.
- All Beach Waterpark Rules (attached) must be observed, or dismissal and loss of privileges will result. Additional rules are posted at the Beach Waterpark.
- No alcohol or glass is permitted anywhere inside the facility or on park district premises.
- Cancellations must be made one week prior to the rental. If not made within one week, a cancellation fee of \$25 will be assessed.
- There are NO REFUNDS for cancellations for inclement/questionable weather. If given enough notice, we may be able to reschedule to a different date.



## BEACH WATERPARK RENTAL OPTIONS

### Option 1: Private Rental

The Beach Waterpark can be rented during hours when the pool is not open to the public or in use for park district programming. A minimum of two (2) hours is required.

### Option 2: Semi-Private Rental

By renting as a semi-private, your group will receive admission at a reduced group rate. Semi-private rentals occur during regular operational hours. Guest count includes non-swimming attendees. At the conclusion of a semi-private rental, guests are allowed to stay and use the facility.

## **Rental Agreement**

1. All individuals are expected to follow Beach Waterpark rules as established by the Wood Dale Park District.
2. All guests, including non-swimming guests, must be part of the total guest count.
3. Children twelve years and under will not be permitted without a parent or adult guardian.
4. The Children's Water Playground may be used by children seven years and younger who are accompanied and supervised by a parent or an adult guardian (18 years or older).
5. Alcohol, glass, gum, or tobacco will not be permitted. Plastic water bottles and baby bottles are permitted.
6. Individuals are expected to obey lifeguards and staff.
7. Diving is not permitted at any time.
8. The Wood Dale Park District reserves the right to eject any individual involved in acts of misconduct.
9. All people are required to read and obey any posted rules and signs. Failure to read and obey these rules may result in a warning or waterpark ejection.
10. All patrons must wear swimwear.
11. Admission to the waterpark may be refused to any person showing signs of or having any contagious or infectious conditions or diseases.
12. Children who are not completely toilet-trained shall wear tight-fitting rubber or plastic pants, which are approved by the DuPage County Health Department. Children with diapers will NOT be permitted in the Water Playground area UNLESS wearing tightly fitting rubber or plastic pants, approved by the DuPage County Health Department, are worn over the diapers.
13. The Wood Dale Park District and its staff are not responsible for lost or stolen items.
14. Any outside vendors and entertainment must be approved by the Wood Dale Park District. A Certificate of Insurance may be required.
15. There will be no "floaties", noodles or any other toys allowed in the facility at any time.
16. Park District staff have the right to stop any activity that is identified as unsafe or inappropriate.

## **IMPORTANT INFORMATION**

The Wood Dale Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Wood Dale Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational activities.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

## **WARNING OF RISK**

Swimming is intended to challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including drowning. Understandably, not all hazards and dangers can be foreseen. The very nature of swimming is hazardous and risky, including but not limited to fatigue and overexertion, poor swimming skills, failing to avoid dangerous areas, horseplay, diving or cannon-balling into shallow water and striking the bottom or side of the pool, inadequate supervision or instruction, lack of conditioning, becoming disoriented, striking other swimmers, defective or inadequate equipment, striking one's head on the bottom when using a diving block, slip and falls on the deck or within the locker facility, chemical exposure and all other circumstances inherent to the sport of swimming. In this regard, it must be recognized that it is impossible for the Wood Dale Park District to guarantee absolute safety.

## **WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK**

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity (including transportation services and vehicle operations, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against Wood Dale Park District, including its officials, agents, volunteers and employees.
